CONTRACT WITH EXHIBITOR

BOOKING

1. Booking of Exhibition Hall No. 1,2 & 3 along with Foyer Area and Main Auditorium of Expo Centre, Johar Town, Lahore is made for 7 days i.e. 14-15 & 16 February, 2022 (3 days) for buildup of stalls/Booths, **17- 18 & 19 February, 2022 (Thursday, Friday & Saturday) would be Actual Exhibition (3 Days) and 20th February, 2022** for dismantling.
2. Booking of Stalls was commenced just after closing of IPEX-2019 on the principles of First Come First Serve Basis along with 25% advance Payment, Provided there is no outstanding of Previous IPEX's against such company.
3. All potential exhibitors are requested to send requests for allotment of stalls **along with current dated crossed cheque of 25% of** the total cost of the stall in advance, incase the company has not yet booked any Booth/Stalls. Provisionally stalls would be allocated but it will be **confirmed on receipt of remaining 75% amount** before 31 December, 2021
4. Confirmation of stalls will be communicated to the allottees by 31 December, 2021 on receipt of full Payment.
5. The companies booking two Blocks of size 6x12 mtr stalls, would be allowed to include passage area Between the 2 Blocks free of cost.
6. In case of more requests for a particular stall are received, preference will be given to those, who would demand more stalls in the Same Block. (For example: A is demanding 4 stalls number 1,2,3,4 and B is demanding 1&2 . The preference will be given to A). The decision of the Exhibition Committee will be the final.

CANCELLATION

7. If a stall is cancelled after booking or fail to make full payment up till 31st December 2021, 25% of the full cost will be forfeited by PPA / IPEX and the same stall will be allocated to other interested companies.
8. If the stall is cancelled after 1st January, 2022, and before 15th January 2022, 50% of full payment will be forfeited by PPA/ IPEX.
9. If the Stall is cancelled after 15th January 2022, 100% Payment will be Forfeited.

GENERAL RULES

10. The Rules & Regulations and SOPs during the Exhibition are appended below for compliance. It is hoped that all the exhibitors would extend their full cooperation:-

- a. Shells would only be provided to 4x2 Mtrs Stall/Booth and for remaining Stall/Booth only bare space will be given.
- b. Maximum Height of the Booth / Stall would be 16 Feets the maximum
- c. Sound Level at stalls would be maximum (70 dBA) decibel reading, up to 02:00 pm daily according to Public Disturbance Noise Regulation. There would be no check after 2:00pm.
- d. No Company is allowed to sublet the Stall/Booth. They have to utilize the allotted stall by themselves, with their company name.
- e. All Booths would be Fabricated by the Registered Vendors of PPA only.
- f. Prizes / Shields will be awarded to 1st three position holders of exhibition, (Owners of the Stall/Vendors)
- g. These are final terms & conditions by the Organizing Committee. If there is any change in above mentioned terms & conditions, that will be circulated to all in writing. No verbal communication will be considered.
- j. At the time of booking exhibitors are required to provide their consent to accept the above mentioned contract.

ARBITRATION

11. Any disputed matters will be referred to the Exhibition Committee of IPEX -2022 for resolution. The decision made by the committee will be considered final. No company would have right to go to any **court of law** against the decisions of Organizing Committee & All committees constituted by IPEX-2022 of Pakistan Poultry Association (N.R)

12. Due to unavoidable circumstances Exhibition Committee reserves all the right to **re-Adjust, change or cancel** the allocated stall location, even though full payment has been received.

 - All Foreign Companies Booking Booth would Pay its Charges in US Dollars.
 - USD-50 incidental charges will be added in each foriegn transaction.
